General Counsel and members of the public in attendance. Discussions included transactional brokerage, agency agreement, and agency relationships.

201 KAR 11:121, Professional standards of conduct included all sections with changes and corrections being established by KREC Commissioners with the assistance of legal guidance of the KREA General Counsel and members of the public in attendance. Discussions included professional conduct, submission of written offers, gross negligence, disclosures, agency agreements, affiliations and changes to the advertising sections being relocated to 201 KAR 11:105, Advertising.

After the recess, the Commission continued discussion of dual agency, designated agency, and team agency definitions, rules, and scenarios.
