Ann Disponett, at 11:17 am on Thursday, May 23, 2019. Guests in attendance were welcomed and introductions of guests, staff, and commissioners were made that included special guests of the Chair, daughter, Anna Marie and Father, Dave Disponett. Roll call was taken and a quorum was present.

Approval of Meeting Minutes

Commissioner Beckham made a motion to approve the April 18, 2019 Full Commission Meeting Minutes. Commissioner Hayden seconded the motion. With all in favor the motion carried.

Commissioner Hayden made a motion to approve the April 25, 2019 Special Regulatory Review Commission Meeting Minutes. Commissioner Beckham seconded the motion. With all in favor the motion carried.

Commissioner Hayden made a motion to approve the May 6, 2019 Special Regulatory Review Commission Meeting Minutes. Commissioner Beckham seconded the motion. With all in favor the motion carried.

Education and Licensing Report

Legal Report

General Counsel Becker addressed to the Commission an email seeking clarification regarding issue of dispersing commission checks and authority of a brokerage having contracts stored in electronic storage.

There was no docket report for this meeting.

General Counsel Becker presented to the Commission information to consider regarding future Education grants. The Commission discussed pros and cons with various types of grant options.

With Commission interest, General Counsel Becker agreed to follow up the issue and bring back to the Commission for further review.

Commission Regulation Review Discussions

General Counsel Becker began the current regulation review of 201 KAR 11:011, Definitions, 201 KAR 11:105, Advertising, 201 KAR 11:121, Professional standards of conduct, 201 KAR 11:170, Education providers, 201 KAR 11:190, Complaints and discipline, 201 KAR 11:210, Licensing, 201 KAR 11:220, Insurance and 201 KAR 11:461 Repealer.

Discussions of 201 KAR 11:011, Definitions, 201 KAR 11:105, Advertising, 201 KAR 11:121, and Professional standards of conduct included all sections with changes and corrections being established for recommendation by KREC Commissioners, with the assistance of legal guidance of the KREA General Counsel and from the KREA Executive Director.

A motion was attempted but not completed by Commissioner Hayden and Commissioner Beckham to approve all proposed regulations subject to changes and amendments, however it was then deferred for further discussion and motions later during the meeting.

Recess

Commissioner Chair, Disponett recessed meeting for brief lunch and reconvened the meeting at 12:45 for lunch and reconvened the meeting at 1:24pm.

Commissioner Hayden made a final motion after withdrawing previous motions to approve the proposed regulations for 201 KAR 11:170, Education providers, subject to updated amendments of evaluation forms. Commissioner Beckham seconded motion. All in favor, motion carried.

After the Commissions extensive discussions, Commissioner Hayden made a final motion to approve the proposed regulations for 201 KAR 11:105, Advertising. Commissioner Cline seconded the motion. All in favor, motion carried.

During portion of this meeting General Counsel Becker gave clarification of three types of regulation to better understand 201 KAR 11:461, Repealer.

- 1. New Regulation has not been introduced
- 2. Amendment of Regulation changing existing regulation
- 3. Repealing Regulation deleting changes to new or existing regulation
