#### Call to Order and Guest Welcome

The Kentucky Real Estate Commission meeting was called to order by Commissioner Disponett at 1:35 P.M., February 11, 2020.

#### Roll call

Roll call was taken by Commissioner Disponett and a quorum was present.

#### **Approval of Meeting Minutes**

Commissioner Beckham made a motion to approve the January 16, 2020 Commission Meeting Minutes. Commissioner Disney seconded the motion. With all in favor the motion carried.

#### **Education and Licensing Report**

#### **Approvals**

February 2020 Continuing Education Courses were reviewed and recommended for approval by Ms. Carlin. They all meet KRS 324 and 201 KAR Chapter 11 minimum requirements. Commissioner Beckham made a motion to approve the "attached list of courses." Commissioner Amann seconded the motion. Commissioner Disney and Commission Chair Disponett both abstained from the vote. With all in favor the motion carried.

#### **Hardship Requests**

Ms. Carlin asked the Commission to review two (2) education hardship requests asking for their \$500 fine to be waived. Commissioner Simpson made a motion to disapprove both requests. Commissioner Beckham seconded the motion. With all in favor the motion carried to deny the requests.

#### **Statistics**

Ms. Carlin presented a list of January 2020 education and licensing statistics (see attached).

#### **Compliance Course & KY Core**

Ms. Carlin asked the Commission for updates or comments on the new versions of the Licensee Compliance Course and the Kentucky Core Course, recommending their approval. Commissioner Beckham made a motion to approve both courses. Commissioner Disney seconded. With no opposition, the motion carried.

Ms. Carlin reminded those present that renewal 2020 opens on Monday, February 17, and they need to renew their E&O policy first. Ms. Mullikin encouraged principal brokers to renew before their agents so they do not get cancelled thereby cancelling everyone in the company. Commissioner Disponett mentioned that this year will be different because the renewal is for two (2) years.

#### **New Business**

Commissioner Disponett said she is happy to report that we are still working with Ohio on a reciprocity agreement. Only one word is changing to make the contract complete. Tennessee, Illinois and Indiana have all reached out to KREC to work on agreements as well.

Commissioner Disponett discussed forms from the last meeting. Per our legal team, the forms currently on the website must be used until new forms are available. Brokers and sales associates will be notified when it changes. Commissioner Amann noted that there is a grace period through June 1 to use the forms that are currently posted.

#### **Approval of Travel & Per Diem**

Commissioner Beckham moved to approve travel and per diem for regular and special meeting dates of the month of February 2020. Commission Simpson seconded the motion. With all in favor, motion carried.

#### **Meeting Adjournment**

Commissioner Simpson made a motion to adjourn the meeting. Commissioner Beckham seconded the motion. All in favor, the meeting adjourned at 1:57 P.M.
