Call to Order and Guest Welcome

The Kentucky Real Estate Commission (KREC) Applicant Review Committee (ARC) meeting was called to order through Zoom by Commissioner Sickles at 9:11 a.m. Roll call was taken, and a quorum was present including Commissioner Hamilton. Approval of Meeting Minutes

- 2. Motion to recommend probationary approval for J.M.S.W. for one (1) year with quarterly National Criminal History Check (NCHC) self-reports every three (3) month showing no new charges. The motion was seconded by Commissioner Hamilton. All in favor, the motion carried.
- 3. Motion to recommend deferral for further investigation on M.M. and Q.W. The motion was seconded by Commissioner Hamilton. All in favor, the motion carried.
