Commissioner Disney asked Ms. Carlin to set up an 'Item Review of the State Exam' meeting. Suggesting that it might be a good time to work with the exam providers. Ms. Carlin responded she would contact the testing provider about scheduling the review this fall.

## Ms. Carlin presented the June 2022 licensing requests:

With the caveat that, due to the medical hardship of the requester, the Commission may need to be revisit at a later date. Commissioner Disney seconded the motion. Having all in favor, the motion carried.
- 3. **181103:** Commissioner Carter made the motion to deny. Commissioner Simpson seconded the motion. Having all in favor, the motion carried.



- 4. **220929:** Commissioner Simpson made the motion to deny. Commissioner Sickles seconded the motion. Having all in favor, the motion carried.
- 5. **222460:** Commissioner Simpson made the motion to deny. Commissioner King seconded the motion. Having all in favor, the motion carried.
- 6. **278194:** Commissioner Simpson made the motion to deny. Commissioner Sickles seconded the motion. Having all in favor, the motion carried.
- 7. **278239:** Commissioner Sickles made the motion to deny. Commissioner Disney seconded the motion. Having all in favor, the motion carried.

Ms. Carlin announced that the public comment hearing for the proposed amendments to 201 KAR11:121 and the previously promulgated forms will be on June 22, 2022 at 10:00 a.m. in PPC Conference Room 127CW, here at the Mayo Underwood building. A zoom link will also be posted to the website for those interested in attending.

Ms. Carlin stated that the public comment period doesn't end until June 30, 2022. Once the public comment period concludes, the Commission will call a special meeting to formulate an official response to each comment received.

## **Executive Director Comments**

Director Astorino gave a brief update on KREA staffing and the upcoming relocation of the Kentucky Real Estate Appraisers Board to Frankfort.

Director Astorino concluded his report by summarizing his visit with the National Association of Real Estate Brokers (NAREB), which is an organization focused on diversity in the real estate industry. He plans to continue a developing a relationship with that group to further KREC diversity, equity, and inclusion initiatives.

#### **Committee Reports**

## Diversity, Equity, & Inclusion Committee

Commissioner Carter provided additional information about NAREB, which began because minority real estate licensees were not allowed to become members of the National Association of Realtors. The existence of groups, such as NAREB, is vital to community outreach.

Commissioner Disney contacted someone at Berea College regarding the DEI scholarship. The Berea College representative seemed interested in the initiative and wanted to discuss it further once campus opened this fall.

Commissioner Sickles reached out to Simmons College. They have asked KREC to come speak and do presentations on real estate careers at their business school and other organizations.

Commissioner King read the report of the Application Review Committee and the Committee's

At 9:46 a.m. Commissioner Sickles made a motion to enter executive session, pursuant to KRS 61.810(1)(c) and (j), and KRS 61.815 to deliberate on individual adjudications and to discuss the four (4) new applications as offered by the ARC Committee and four (4) complaints as offered by the CRC Committee.

Commissioner Disney seconded the motion and the Commission entered into executive session discussion.

Commissioner Simpson motioned for the Commission to come out of executive session. Commissioner King seconded the motion. Commission Chair Disponett resumed the full Commission meeting at 10:56 a.m. and welcomed everyone in attendance back to the teleconference Commission meeting.

Tom Cox summarized his issues with obtaining a reciprocal license in Florida. The Florida Real Estate Commission won't grant him a reciprocal license because he obtained his Kentucky license through a reciprocal agreement with Indiana in 1997.

LuChyna Kimbrel asked in reference to the decision made by the Commissioners, what is she supposed to do to move forward. Counsel Walburn informed her that she would be receiving written determination that will contain additional information about what would happen next.

Joyce Sterling asked if the testing services was still PSI? Ms. Carlin affirmed PSI is still the Commission's testing provider.

Richard Wilson, KYR asked if the public comment results meeting would be the same as the regularly scheduled July meeting? Ms. Carlin noted that the decision had yet to be made, but information would be posted to the website once it was decided.
