Executive Director Comments

Director Astorino made welcoming comments and thanked everyone present for attending the meeting. He was proud to report that KREA has grown into a staff of sixteen full time and one intern of very competent and knowledge-based individuals. He feels that the agency is now structured, in his opinion, to fulfill the job the way the statute intended. He offered a special thanks to General Counsel Molly Cassady and Deputy Executive Director Carlin for their assistance in assembling this team. He feels KREA has a very solid staff.

It is with reluctance that he reports that KREA will be losing General Counsel, Molly Cassady. Ms. Cassady has been reappointed to the Department of Housing, Buildings and Construction (HBC) within the Public Protective Cabinet. They have an urgent need for her assistance.

KREA has a new General Counsel, August Pozgay. Mr. Pozgay comes from the Department of Professional Licensing, where he represented state boards of licensure. He thanked the Commission and looks forward to working with them.

Director Astorino noted that he and staff were still working towards a reciprocity agreement with Illinois. He thanked Commissioner Disney for introducing him to the Deputy Director of the Georgia Real Estate Commission, who expressed an interest in an agreement with Kentucky. Georgia is a recognition state. He will be meeting with them soon.

Executive Session Legal Matters and Case Deliberations

Commissioner Day seconded the motion and the Commission entered into executive session discussion.

Commissioner King moved for the Commission to come out of executive session. Commissioner Sickles seconded the motion. Commission Chair Disponett resumed the full Commission meeting at 10:36 a.m. and welcomed everyone in attendance back to the teleconference Commission meeting.

As per the terms of the Agreed Order, additional items will be listed in next month's meeting minutes. Commissioner Carter seconded the motion. Having all in favor, the motion carried.
- 3. **22-KREC-004** Commissioner Disney made a motion to approve the terms as presented by the applicant. Commissioner Simpson seconded the motion. Having all in favor, the motion carried. The applicant's proposed terms will be incorporated into a proposed Agreed Order.

Legal Report

Ms. Cassady took the opportunity to express how much she had enjoyed working for the Authority. She stated that there is an amazing staff who all work very, very hard for each of the boards at KREA. While saddened to be leaving she felt that she has left KREA in good hands with the new legal team. She thinks that they're going to do amazing things. She thanked everyone for how well she had been treated during her tenure. If ever needed she will on the first floor of the building.

General Counsel Pozgay thanked Ms. Cassady for her kind words and for doing such a terrific job for the Authority.

A statement of consideration was filed on August 15, 2022 concerning 201 KAR 11:121. Material incorporated by reference remains under legal review. The forms will need to be submitted to the Administrative Regulation Review Subcommittee as an agency amendment after review and approval by the Commission. Counsel recommended deferral of the regulation package to the following Administrative Regulation Review Subcommittee meeting so the Commission can review the forms.

Commissioner Carter made a motion to authorize General Counsel to request deferral of the forms until the following Administrative Regulation Review Subcommittee meeting. Commissioner Day seconded the motion. Having all in favor, the motion carried.

At this time the Commission and its members thanked General Counsel Cassady for her service.

New Business

KREC Recovery Fund Grant



Ms. Carlin reminded the Commissioners that a couple of months ago they had voted to offer the Education Recovery Fund Grants to any in-state institution that wanted to participate. Those requirements were sent out to contacts who participated in the program last time that it was offered, which was Fall 2020. This is a reimbursement grant. Each university has provided their proposal and their estimated costs.

Commissioner Disney made the motion to approve all three presentations as presented before the Commission. Commissioner Carter seconded the motion. Having all in favor, the motion carried.
