Call to Order and Guest Welcome

The Kentucky Real Estate Commission Applicant Review Committee ("ARC") meeting was called to order through video teleconference by Commissioner Disney at 9:33 a.m. Commissioner Disponett temporarily removed Commissioner James King from the ARC Committee and appointed herself to serve as committee member in his place for this meeting.
