The Kentucky Real Estate Commission ("KREC" or "Commission") special meeting was called to order by Commission Chair, Lois Ann Disponett, at 4:34 p.m. on **April 26, 2023**, having been duly called by the Chair in pursuant to KRS 61.823(2) and noticed in accordance with KRS 61.823(3)-(4). Roll call was taken, and a quorum was present.

Approval of Meeting Minutes

Commissioner Disney made a motion to approve the **April 20, 2023** KREC Meeting Minutes, Commissioner Day seconded the motion. With all in favor, the motion carried.

Legal Report

General Counsel Pozgay presented a request to consider comment concerning Administrative Regulation in process 201 KAR 11:121. The request was relayed through the Legislative Research Committee (LRC) staff from Senator West. Sen. West asked that the Commission consider the constituent's comments.

Closed Session Legal Matters and Case Deliberations

At 4:37 p.m. Commissioner Simpson moved to enter closed session, with agency staff and counsel, pursuant to KRS 61.810(1)(k), and KRE 503 to receive legal advice regarding the Administrative Regulation in process 201 KAR 11:121 and Sen. West's request to consider comment. Commissioner Sickles seconded the motion. With all in favor, the motion carried, and the Commission entered into closed (executive) session.

Reconvene Open Session and Committee Recommendations

Commissioner Simpson moved for the Commission to come out of closed session. Commissioner Disney seconded the motion. The motion carried. Commission Chair Disponett resumed the full Commission meeting at 4:59 p.m. and welcomed everyone in attendance back to the Commission meeting.

Chairperson Disponett noted for the meeting minutes that the Commission duly considered the content of the referred request to consider comments regarding 201 KAR 11:121 and no action was taken.

Commissioner Carter made a motion to authorize General Counsel to inform the referrer that a Special Meeting was held, and no action was taken. Commissioner Day seconded the motion. With all in favor, the motion carried.

Commissioner Carter made a motion to authorize General Counsel and the KREC Chair, or designee of Chair, to attend any upcoming Legislative Research Committee meetings where regulation 201 KAR 11:121 may be discussed. Commissioner Day seconded the motion. With all in favor, the motion carried.
