Commissioner Day seconded the motion, and, with all in favor, the Commissioners entered into closed session.

Reconvene Open Session

Commissioner Sickles moved to come out of closed session and Commissioner Day seconded the motion. With all in favor, the Kentucky Real Estate Commission Meeting resumed in open session at 10:13 a.m. EST.

Commissioner Day made a motion to defer applicants H.J. and M.B. to the February 18, 2025, ARC Meeting. Commissioner Sickles seconded the motion. With all in favor, the motion carried.
