The Kentucky Real Estate Commission ("KREC" or "Commission") meeting was called to order by Commission Chair, Lois Ann Disponett, at 10:00 a.m. on **September 11, 2023**. Roll call was taken, and a quorum was present. Guests were welcomed and an introduction to staff and Commissioners were made.

Approval of Meeting Minutes

Commissioner Simpson made a motion to approve the **August 17, 2023** KREC Meeting Minutes, Commissioner Disney seconded the motion. Having all in favor, the motion carried.

Deputy Executive Director Hannah Carlin reported that KREC had its routine Criminal History Record Information Audit conducted by the Kentucky State Police (KSP). Commissioner Simpson made a motion to instruct KREC staff to post the **FBI bulletin**, titled **"How to Challenge and How to Obtain Your FBI Identity History Summary"** on the KREC website and to authorize staff to instruct the license examination vendor to provide it along with the KREC license application., Commissioner King seconded the motion. Having all in favor, the motion carried.

Meeting Adjournment


Commissioner Simpson made a motion to adjourn the meeting. Commissioner Day seconded. With all in favor, the meeting adjourned at 10:18 a.m.
